Nutrition Counseling Nutrition Education, Transportation, Information & Assistance, Outreach, Medical Transportation, Adult Day Health Care, Case Management, Group Respite, In-Home Respite, Individual Counseling, Material Aid, Personal Care, Caregiver Public Education, Caregiver Sitter Service, Support Group, Counseling, Crime Prevention, Homemaker, Legal Assistance, Medical Alert, Medication Management, Recreation, Companion Care, Telephoning, Utility Assistance, Visiting, and Wellness. Other services provided through GOEA are Elderly Protective Services, Long Term Care Ombudsman, Aging and Disability Resource Centers (ADRC), SenioRx Prescription Assistance, National Family Caregiver Support, Community Living Program, Alzheimer's disease Supportive Services Program and the Senior Employment. GOEA is currently planning provider agreements to begin implementing the Veterans Directed Home and Community Based Services Program through a partnership with GOEA, the ADRCs and COAs and the Federal Veterans Health Administration.

# <u>Program Name:</u> Elderly Protective Services (EPS)

EPS is mandated by Louisiana revised statute 15:1501et seq. to prevent remedy halt or hinder acts of abuse and neglect against an older person in the community while promoting the maximum degree of personal freedom dignity and self-determination for that individual. Elderly Protective Services has seven regional offices to respond to reports the abuse neglect and exploitation. EPS is State operated with four direct State offices and three offices contracted to local providers.

The purpose of Elderly Protective Services (EPS) is to protect adults who cannot physically or mentally protect themselves and who are harmed or threatened with harm through action or inaction by themselves or by the individuals responsible for their care or by other persons.
