New Opportunities Waiver

 The Community Choices waiver will replace the EDA waiver effective October 1, 2011. The Community Choices Waiver will include a more comprehensive menu of services, including home delivered meals, assistive devices and medical supplies, and non-medical transportation, in addition to the services currently offered under the EDA waiver.

Money Follows the Person

- Approximately 179 individuals have transitioned through the MFP program since fall 2009. Year-to-date, approximately 82 individuals have transitioned through the MFP program.
- To help address housing issues, an application has been made for a Real Choice Systems Change partnership grant. OCDD is directing this activity.
- The Quality of Life survey contractor began work in April and continues to timely collect survey data at transition and at the 11-month and 24-month follow-ups.
- MVA continues to collaborate with OBH to leverage the 1915b waiver and proposed 1915i state plan amendment into the MFP demonstration. The waiver and state plan documents have been forwarded to CMS, but not yet approved.

Self-Direction

- There are currently 105 recipients participating in the self-direction option, as of September 13, 2011.
- A three year contract has been awarded through the Request for Proposal process to Acumen Fiscal Agent to perform fiscal management services effective August 1, 2011.

General Medicaid Issues Affecting the DD Population

Budget Reductions

For FY12, as HB1 stands today, we are fortunate that no new provider cuts are anticipated to be made to the DD population.

Statewide Management Organization Contract

Act 343 of the 2007 Regular Legislative Session directed DHH to establish a Statewide Management Organization (SMO) to oversee all behavioral health services. An SMO contract will allow Medicaid to better utilize the services which exist, cut costs per individual served, reduce fraud, increase the use of evidence-based interventions among providers and increase the availability of qualified mental health providers throughout the state. An SMO contract also has the potential to reduce redundancies throughout state agencies, expand services including substance abuse treatment and residential services, and target youth at risk for out of home placements.
